Subject: Filing under Clause 36- Hon'ble Company Law Board, Mumbai Bench order dated January 29, 2015 received by the Company on February 13, 2015

Dear Sir/Madam,

1. This is with reference to the above referred order of Hon'ble Company Law Board, Mumbai Bench.
2. Certain group of shareholders Ketan K. Shah & Others, (the Complainants) have filed a Company Petition before Mumbai Bench of Hon'ble Company Law Board being CP No. 101/397-398/CLB/MB/2014 titled as Ketan K. Shah & Ors. Vs. HOV Services Limited & Ors., against the 3 resolutions put before the shareholders by the Company vide its Notice of Postal Ballot dated September 30, 2014.
3. The results of postal ballot where in the shareholders have approved all 3 resolutions with requisite majority, was filed with your office vide our letter dated November 4, 2014.
4. The Complainants have filed the Petition as above mentioned. The matter was heard by Hon'ble Company Law Board, Mumbai Bench on dates as mentioned below:
 - i) First hearing was held on November 13, 2014 wherein the Company had raised preliminary objection challenging the validity of the Consents given by shareholders-members to institute the said petition and pointing out defects in the Consent Letters given by respective Petitioners to file the present petition on their behalf. The Hon'ble Company Law Board, Mumbai Bench heard the submission and directed Petitioners to submit their response with two weeks here from and granted December 9, 2014 for subsequent hearing date. **(Annexure I)**
 - ii) Second hearing was held on December 9, 2014, the Petitioners had sought further time be allowed for their filings. The Hon'ble Company Law Board, Mumbai Bench allowed a week time to file as prayed for and directed the matter for final hearing on January 29, 2015. **(Annexure II)**
 - iii) On January 22, 2015 the Company prayed to close the right of the Petitioners as they are gaining time and was not able to file their submission with in stipulated time. The Hon'ble Company Law Board, Mumbai Bench considered the prayer of the Company. **(Annexure III)**
 - iv) Final hearing was held on January 29, 2015, the Petitioners sought permission to withdraw the instant Company Petition. The Hon'ble Company Law Board,

C.P.No. 101/2014

1. C.P. mentioned. The Petitioners, who are 102 in numbers, have invoked the provisions of Section 397/398 r/w Section 402 of the Indian Companies Act (hereinafter referred as "the Act" in short) by way of filing the present petition. The Petitioners, in their petition, have alleged various acts of oppression and mismanagement purportedly committed by the Respondent Nos.2 to 6 in the affairs of the Respondent No.1 Company (hereinafter referred to as "the Company" in short), and they have also sought the reliefs as set out in the Petition.

2. Pursuant to the advance notice, the Ld. Counsel for the Respondents appeared. The Respondents have raised a preliminary objection challenging the validity of the Consents given by the shareholder-members, the Petitioners herein, to institute the present petition u/s 397/398 of the Act. On merits, the Ld. Counsel has submitted that in case the preliminary objections objection raised on behalf of the Respondents are not found favour by the CLB, the Respondents may be allowed time to enable them to file their reply(s) before interim prayers are considered.

3. On the other side, the Ld. Counsel appearing on behalf of the Petitioners refuted the contentions as to the maintainability of the Petitioner raised by the Respondents, and also argued on merits of the case saying that pending the hearing and final disposal of the Petition, the Respondents, their servants, agents and assigns may be restrained by an order of injunction from giving effect to and/or implementing the Resolutions passed in the General Meeting purportedly held on 30/9/2014 and the purported Special Resolution passed on 4/11/2014.

4. I have considered the submissions, supported with case law, advanced by the Ld. Counsels appearing on behalf of the respective parties at length. Certain valid points have been raised by the Respondents' Counsel pointing out defects in the Consent Letters given by the respective Petitioners to file the present petition on their behalf. However, in my opinion, it will not be just and proper to dismiss the petition at the threshold stage on these technical points. To secure the ends of justice, it deems appropriate to give an opportunity to the Petitioners to rectify the defects pointed out by the Ld. Counsel appearing for the Respondents in the Consent Letters.

5. In so far as the prayers for grant of ad-interim reliefs are concerned, admittedly, the EOGM has already been held, whereat impugned Resolutions have already been passed. It appears that the Resolutions have also been implemented to some extent. Keeping in view the above facts, it does not seem just and proper to pass any ad-interim order without giving an opportunity to the Respondents to file their reply(s) to meet out the allegations of the Petitioners. I, therefore, pass the following directions:-

(a) The Petitioners, whose signatures appearing on the Consent Letters did not match with their signatures appearing on the record of the Company, shall file affidavit along with their photographs.

(b) The Petitioner Companies, who are said to be the shareholders/members of the Respondent No.1 Company will place proper resolution(s) authorizing the person to file the petition on their behalf.

(c) The Petitioners may also take appropriate steps to implead the transferee Company as a Respondent in the array of the parties to the Petition.

(d) The Respondents may file their reply(s) within two weeks herefrom, to which the Petitioners may file a rejoinder, if any, before the date fixed. Along with the reply, the Respondent Company shall also file the valuation report, which it had purportedly obtained for the purpose of sale of the subject property.



6. List the C.P. on 9th December 2014 at 10.30 A.M. for hearing in respect of the interim reliefs.




